Amended AB 86 and a Return to In-Person Instruction

As you likely heard last week, Governor Newsom and our State Legislature reached agreement on incentives for offering in-person instruction by April 1st for TK-2 and small cohorts. We are still looking at the information closely along with CTA, but here is what I want to make sure you know:

- CVUSD has not completed a safety plan, which is required to be approved by both the county and the state and posted on the District website before we can offer in-person instruction.
- We still have not finished negotiating a Hybrid MOU, and neither has CSEA.
- Our CVUSD School Board has not selected a date yet to offer in-person instruction.
- The agreement reached by the governor and legislature is an incentive for extra money, not a mandate for current money we receive.
- You can read CTA President E. Toby Boyd's statement about this agreement here

We will keep you informed as things change and move along. At this point, though, you should have already requested accommodations if needed (get it in if you still haven't done this). Part of what we are negotiating in the MOU is how people will be selected to teach the in-person Hybrid

classes, so we are not able to answer questions about that yet.

Clarification on Opting Out of Testing and a Member's Rights

Last week I shared a link to CTA's page about your rights to inform parents about opting out of testing. Click here if you missed it last week

Please be sure to read it carefully! Here is a summary:

- You may inform parents of their right to opt their children out of testing.
- You may share the website with them if they'd like more information (cta.org/optout).
- You may not suggest to a parent that they opt their child out of testing (even if they ask for your opinion).
- You may not seek out only one or two parents with whom to share opt out information. If
 you are going to contact one parent with the information, you should contact all parents.
 An exception to this is if one parent reaches out to you, you may inform that parent of
 his/her rights and share the website, but you are not then obligated to contact all of your
 other parents.

While the District is required to test 95% of their students each year, that has no effect whatsoever on your right to inform parents. The District may choose to include opt out information in letters they send to parents regarding testing, but that also has no effect on your right to inform parents.

There is definitely a convoluted process to access the meetings or to submit public comments. Hybrid Prep Site Visits

I continue to make site visits to see the classroom and school site set ups for teaching in person. The number one concern we have is that all safety guidelines will be followed in the Hybrid Model, so I will be looking specifically for what the School Board has been told is happening at sites in preparation. This includes the plexiglass barriers, the air filtration, the distance between students as well as students from teacher, sanitizing stations, one way path markings, etc. Each week I will give an update about what I've seen. We do recognize that it is nearly impossible to be fully set up not knowing yet which teachers will remain in Distance Learning and which will return to in-person instruction, so we are looking for sample classrooms planned at various grade levels.

- VV This site is pretty much ready in theory, just a couple small things to correct. Well
 thought out in order to provide the safest environment for both students and staff. Of
 course everything is not set up completely due to not having a specific hybrid opening
 date.
- DM Another site that is mostly planned in theory, but not fully set up as they are waiting for a specific date and final numbers. Visited a couple of classrooms that were set up and saw other items they are still working on.
- AE AE was by far the most prepared site I've visited. They could provide in-person


- instruction today if it was possible. No recommendations needed at this site.
- This week visiting: ECE. That's it! I've visited all sites after that, but may need to go back for a follow-up at some to make sure things were corrected.
