At a time we need more support than ever, we received training on things we didn't have access to, as well as trainings that were clearly put together last minute (presenters even shared they had no time to prepare!).

Mr. Salomon Alvarez, more affectionately known by his thousands of students as "Señor" or "Mister", passed away on July 24th, 2020, at JFK Memorial Hospital in Indio, California. He is survived by his wife, 2 sons, and 5 grandchildren. Mr. Alvarez left a legacy that displayed a passion for education and coaching, inspiring his students and his own children to push themselves harder and use each opportunity in life as a moment for learning and improvement. Even in the most difficult of times or circumstances, Mr. Alvarez leaned on his love for the Lord to persevere and stand firm from a place of faith and integrity. It's this love that allowed him to excel in his genuine care for all of his students; always wanting the best for each one. Born in Indio, California in the year 1947, Mr. Alvarez was a proud graduate of CVHS's class of 1965, and a proud member of the Coachella Valley's first CIF state champion (American football). He began his dream profession of becoming an educator by starting as a teacher's assistant in 1992 and worked tirelessly to complete his bachelors and masters degree. After thousands of miles and hundreds of hours completing weeknight and weekend courses, Mr. Alvarez became the first of his family to receive an advanced degree. Later in life, his dream of traveling the world was able to become a reality and he extended that passion to his students, whom he would organize and take on an annual trip to the Iberian Peninsula. These trips were not merely for vacation, rather they were educational; an opportunity to expand the mind across various cultures and languages, bringing home the importance of anthropology and personal growth. Mr. Alvarez forever had CVHS and Desert Mirage HS close to his heart. His unexpected departure leaves a large void in the lives of the thousands of individuals who have counted him as a mentor, and certainly for the family that loves him dearly. However, we take comfort that he is rejoicing with our Heavenly Father and Lord willing, we will see him again.
